Australian Apprenticeships Incentive System (AAIS)

VIC	Wages are exempt for where a recommenced apprentice or trainee is employed by another employer and is continuing with the same type of approved training contract. NSW	Apprentices only – Premium reductions are available, to be eligible employers must have a valid workers compensation policy and the apprentice registered under an approved training contract	iCare www.icare.nsw.gov.au
VIC	Employers can claim an exemption for wages paid to apprentices and trainees employed under a registered training contract. Trainees – to be eligible, the trainee remuneration for 2023/2024 must be \$53,210 or less (inclusive of superannuation) Apprentices – there is no cap on apprentice remuneration.
